THE MAAGS OF BACHENBÜLACH

BACKGROUND

oak family tradition, from "Jacob Moak of New Scotland" by Martha Slingerland and Grace Moak, holds that Hans Jacob Moak of New Scotland, New York, came to America from Switzerland. Anna Mook, who married JacobArnold on 10 Nov 1751, is presumed to be his sister. Both Johannis Mook, who married Barbara Beekman in Schenectady in 1756, and Francis Moak, who married Engeltie Slingerland on 15 Oct 1759, are of an age to be siblings to Anna and possibly Hans Jacob.

In "Early Families of Herkimer County, New York", William V.H. Barker wrote about a Johannes Moak, probably born in Switzerland around 1700. He states that Johannes' wife died at sea and positively attributes Bonocratius (Crotsy) and Sophronia (Veronica) as his children. In "Compendium of Early Mohawk Valley Families", Marily B. Penrose quotes the records of Reformed Protestant Dutch Church, in Herkimer, New York, showing that Grates Mock, who emigrated from Switzerland to America, died 5 Feb 1814 at the age of 88 years.

The earliest entry for Hans Jacob in the Albany church records lists his surname as Moogh. The closest to this in the Swiss Familiennamenbuch is Maag. The majority of Maag family entries in Switzerland are in Zürich Canton, in Bülach parish (in the municipalities of Bachenbülach, Bülach, Hochfelden, Höri, and Winkel), and neighboring parishes (Niederhasli, Oberglatt, Stadel, and Steinmaur).

Albert B. Faust, in "Lists of Swiss Emigrants in the Eighteenth Century to the American Colonies", lists six Maags leaving Bülach parish with their families, four in 1738 and two in 1743. Two of these, Hansz Maag and Hansz Jacob Maag who left in 1738, appear to be the progenitors of the Herkimer and Albany county branches of the Moak family in New York.

The Kirchenbuch, or parish register, for Bülach parish is available on microfilm from the LDS (4 rolls, #0996818 through 0996821). Also available are the Bevölkerungsverzeichnisse, or population registers, for the Zürich Synod covering much of the period from 1633 to 1767 (42 rolls, #1185139 through 1185180). Between 1596 and 1743, there are 245 Maag marriages and over 1050 Maag births listed in the Bülach Kirchenbuch.

Population registers cover the period from 1634 to 1709 in approximately 3 year intervals.

Research of the Maag family of Bülach parish by Julius Billeter is also available (#0193478), but this material contains some errors, particularly in the connections between generations, and should be considered a secondary source.

RESEARCH

According to Faust, Hansz Jacob Maag, Alexander's son, left Bachenbülach with a wife and three children in 1738. There were four families in Bachenbülach in 1738 that had the husband named Hans Jacob Maag and unmarried children below the age of 18. None of these Hans Jacobs were Alexander's son.

Three of the families have birth or death records after 1738. The remaining Hans Jacob married Verena Maag on 6 Feb 1731 and had four children, Anna (bpt 12 Aug 1731), Hans Jacob (bpt 14 Aug 1733), Frantz (bpt 13 Mar 1736), and Johannes (bpt 28 Jan 1738). Billeter lists Johannes' death as 30 Aug 1738, but the actual record translates "Hans Jacob, son of Hans Jacob, 6 months old" and refers to Hans Jacob Maag (bpt 6 Feb 1738), the son of Hans Jacob Maag and Verena Utzinger.

There are only two Alexander Maags in the church records for this time period. The first, bpt 9 Apr 1654, was the uncle of and witness to the baptism of the second, bpt 5 Jan 1679. The second Alexander would appear to be Hans Jacob's father, but there is no record of a son by that name to him. He married Anna Meyer on 21 Feb 1708, and they had four children, Conrad (bpt 4 Nov 1708), Anna (bpt 4 Oct 1716), Veronica (bpt 4 Jul 1719), and Solomon (bpt 10 Apr 1721).

The elder Alexander married Barbara Maag on 26 Aug 1673, and had two children, Veronica (bpt 2 Nov 1673) and Hans Jacob (bpt 12 Nov 1676). Billeter does not show any children for this Alexander. There is a death record for Hans Jacob Maag on 4 Mar 1724 that lists his age at death as 48 years. Billeter confuses this Hans Jacob with Jacob Maag (bpt 9 Nov 1673) born to Johannes Maag and Verena Braun. Johannes' son Jacob married Verena Utzinger on 6 Dec 1701. Alexander's son Hans Jacob married Veronica Maag on 8 Dec 1696 and they had 11 children, including Hans Jacob (bpt 23 Jan 1698) who married Verena Maag in 1731.

There is another record that refers to Alexander

that lends credence to the probability that the emigrating Hans Jacob was actually Alexander's grandson. Another of Hans Jacob's eleven children, Andreas (bpt 14 Oct 1708), married Regula Volkhart on 16 Feb 1734. They had four children, two of whom died before Regula died on 7 Apr 1743. The marriage entry for Andreas Maag, to Regula Utzinger on 18 Jun 1743, translates "Andreas Maag, Alexanders". The younger Alexander did not have a son namedAndreas.

FINDINGS

From the GBülach Kirchenbuch, three of the six Maags emigrating between 1738 and 1743 have so far been identified and the names of their wives and children determined. Two of them, Hans Jacob and Andreas, are brothers and the third, Hans, is their uncle. Table 1 shows the descendency from Jacob Maag, born in 1615, to these three individuals.

Hans Jacob and Andreas' mother, Veronica Maag, was a child of the first marriage of Hans Jacob Maag, to Anna Zander. Hans Maag (baptizedJohannes) was the last child of Hans Jacob's second marriage, to Elsbeth Brunner.

One of the most telling pieces of evidence for the assumption that Han sand Hans Jacob of Bachenbülach are the New York Moaks is the children's names, Pangratz and Frantz. In the period from 1600 to 1745 there were only two Pankratz Maags, one born before 1600, and only one Frantz Maag.

If the Hans Jacob Maag that emigrated in 1738 is Hans Jacob Moak of New Scotland, then the makeup of the first American generation needs to be reconsidered.

Consider first his marriage. If he was born in 1720, then he would have probably married no earlier than 1738. There are no records in the Albany area of this marriage. If he was born in 1698, then he would have been 63 years old when he married Catherine Claassen and 82 when Joseph was born. While not impossible, I would expect to find some other historical reference to an 82 year old father.

It appears that the Hans Jacob that married Catherine Claassen was born in 1733, the son of Hans Jacob and Verena Maag. It explains why childrenwere named Hendrick and Arianna when other children of the same name were still alive. Table 2 shows the descendency from Hans Maag, born about 1594, Hans Jacob's direct line male ancestor, through the firstAmerican generation.

While some of the information matches between Andreas Maag of Bachenbülach and Andrew Moak of South Carolina, there is not enough data present to assume that they are, in fact, the same individual.

According to Lennox L. Moak, in "The Moak and Related Families of South Carolina", Andrew Moak came to South Carolina direct from Europe not earlier than 1738 and not later than 1741. The first record in America of Andrew Moak appears in the Journal of the Minutes of Council of the Province of South Carolina in December 1745 when he applied for a grant of land, having completed his indenture. The indenture was served for "defraying the freight" on a voyage with Captain Stedman.

There are records of Captain John Stedman making a voyage in 1738 as master of the St. Andrew, and of Captain Charles Stedman bringing the Charming Nancy over in 1738 and the St. Andrew over in 1741. Coupled with the supposition that indentures were usually served from three to seven years, it is assumed that Andrew Moak was on one of these ships.

It should be noted that Lennox Moak was unable to identify the nationality of Andrew Moak. He stated, "It is the belief of this author that he was German. He could have been German Switzer. The only indications we have are secondary." He also does not mention of the name of Andrew Moak's wife or the names of two of the three children assumed to be in his family, although the oldest child is assumed to be a son, Hans Jacob.

FUTURE RESEARCH

Billeter assumes that Johannes' wife, Barbara, and Hans Jacob's wife, Verena were sisters. Given other errors that I have found, I will continue to research this.

It also appears that the other three families that left Bachenbülach in 1738 all had Maag wives: Solomon Meyer and his wife Verena Maag (m 10 Dec 1737), Solomon Meyer and his wife Anna Maag (m 1 May 1710) and 4 children, and Heinrich Zander and his wife Regula Maag (m 27 Sep 1729) and 3 children.

Mack and Mock Church Records

in Pennsylvania and Maryland

New Evidence Found

t the Family History Library in Salt Lake City, I located a three volume set of York County, PA, Church Records of the 18th Century. In Volume III I found 'Jacob Lischy's Private Pastoral Record', which includes two MACK baptisms. On page 269, "Peter of Peter Mack and Maria Magd. Erbin, bapt. Feb. 22, 1767. Sponsors: Peter Müller and Maria Marg. Kronin." On page 275, "Jacob of Jacob Mack and Maria Dorothea, bapt. July 15, 1764. Sponsors: Christian Michel and Anna Maria Mackin."

I do not know whether the above baptisms occured in Pennsylvania or Maryland, but I believe the Peter Mack family was most likely living in Maryland during most, if not all, of this time. It appears quite possible that the above fathers, Peter Mack and Jacob Mack are brothers, but no relationship is as yet proven.

According to John Gibson in his 1886 History of York County, PA, page 407, "Rev. Jacob Lischyshortly after 1760....moved to a farm in what is now North Codorus Township, York County, on the right of the road leading from Spring Grove to Jefferson, and nearly midway between the two places. He opened a school and organized an independent church.....in 1765, what is now known as 'Lischy's Church', in that vicinity."

I have also learned that Rev. Jacob Lischy was a traveling minister, who served several congregations and frontier settlements too small to have their own church. Volume 7 of the Maryland German Church Records is devoted to Saint Mary's Church, Silver Run, Carroll County - translated and edited by Frederick S. Weiser in 1986. I quote from his introduction.

"For nearly three quarters of the eighteenth century the line between Maryland and Pennsylvania was in dispute and pioneers from both directions laid claim to the land there. The Conewago settlement, whose heartland was Digges Choice, named for a Marylander who claimed it, also know as Heidelberg township, lay in land eventually in York and Adams counties in Pennsylvania. It was first settled in the 1720s by both British Catholics from Maryland and German Protestants from Pennsylvania. As its population grew, some of the surplus migrated into what has since become northern Carroll County, Maryland, where additional persons coming directly from Europe and also the issue of second generation Pennsylvanians soon joined them.

It was only natural, therefore, that these settlements received ministry from Lutheran and Reformed clergymen living in York County, Pennsylvania, and that these men organized congregations in them when the time was right.

Until they did, however, the earliest settlers of Carroll County went to churches in southern Pennsylvania.

Jacob Lischy, a Reformed pastor who kept a register of the baptisms he performed, was ministering to people named as members of the Silver Run congregations in the late 1750s. By 1762, those Germans living near the Silver Run had erected a church, named it St. Mary's, and were ready to adopt a constitution to govern themselves as a union church. In 1768 the congregations acquired the land on which their church already stood. The clergymen who signed the document were Jacob Lischy, Reformed, and John George Bager, Lutheran. There is every reason to believe the two churches had also begun to use a common record book about the same time.....which unfortunately is lost.

The church building in place by May of 1762 was most likely a log structure.....There is no mention of another church in the records of either congregation until 1821, so that it probably served the congregations for nearly six decades. Of its interior no description has survived. It was sufficiently hale that Peter Mach, one of the members, purchased it for \$90.69, for which he gave three notes [Ledger, page 27.]"

On May 28, 1821 the building of a new "St.Mary's" church was begun, in a nearby, but different location. I believe that the purchase of the old church building and property (I presume) by Peter Mach occured at this time in 1821. The name Peter Mack appears on the first subscription list for the new church, 1821 [Ledger, pages 320-326]. I believe this is the same Peter Mack Jr. baptized in 1767 in the above mentioned record from Lischy's journal. Elizabeth Dieter, widow, is also on the first subscription list for St. Mary's Church (1821). Paul Swan, subscriber to Mock Family Historian, has identified an Elizabeth Deider as the mother of Elizabeth Mock (married to Peter Mock Jr.) and widow of Jacob Deider. Paul Swan is related to this Peter Mock/Elizabeth Deider family, and has kindly shared his research with me (see Spring 1993 Mock Family Historian page 20). Johannes Erb, son of Peter Erb, is also on the list - possibly related to Peter Sr.'s wife. According to Paul Swan's research, "Peter and his wife Elizabeth sold 1 acre of the 'Durbin's Mistake' parcel (Frederick Co. MD) on 9 Apr 1814 to Peter Erb of Christopher for \$30 [Liber WR 47, Folio 482]."

A Peter Mock of Frederick Co. MD purchased 150 acres of the "Brother's Agreement" tract in old Frederick Co. MD, on 10 June 1793, from John Eleanor Thomas. I found that "Brother's Agreement" was a large parcel of land located in and around Taneytown, MD (in a history of Taneytown on the Internet). Peter Mock Senior's grave has been located in the Baust Church Cemetery in Tyrone,

Carroll County, MD (was Frederick Co.), very near to Taneytown, with 3 Apr 1812 at age 85' marked on the headstone. Taneytown is just across the border from old York County, PA, and is less than 25 miles from Codorus Township, York Co. But even more telling, Taneytown is less than 5 miles west of Saint Mary's Church at Silver Run. Tyrone is less than 5 miles southwest of Silver Run.

This appears to be the same Peter Mock Sr. referred to in the 1835 Chancery Court Case heard in Frederick Co. MD. That case listed the heirs of Peter Mock Sr. deceased, intestate (MFH Spring 1993 pg. 20). Peter is cited as having owned 350 acres of "Brother's Tract."

An unrecorded Bedford Co. PA Will, written 6 Mar. 1791 by Jacob MAUK, includes his wife "Merei Dority', and children Dority, Madlelene, Sarah, Mary, John & Jacob. This appears to be the same as Jacob Mack and Maria Dorothea in the above baptismal record.

Also found in early records of Codorus Township, York Co. PA, is "Soldier" George Mack, married to Eva. George served in the Revolutionary War as an American patriot. All three families of George, Jacob, and Peter Mack/ Mauk/ Mock had ties to the Church of the Brethren, but with no proven blood relationship to Alexander MACK, founder of the Brethren.

At Hanover, York Co., as early as 1744, there are records of a John MAAK, perhaps the same

as John and Maria Magdelena MACK, who appear in a 1749 Christ Church record in York Co. This John MACK is considered to be a possible father to "Soldier" George Mack.

I look forward to meeting Fred Ickes, and reviewing his new book on Peter MOCK of Bedford County, at the Mock Conference in Bedford this coming Sept. 26 and 27. And I welcome the opportunity to discuss the above theories and documentation regarding the early Bedford Co. as well as other Pennsylvania and Maryland Mocks. See you all there!!!

Mocks in Montgomery County, Texas

Summarized from the Handbook of Texas, Webb and Carroll, 1952):

"William N. MOCK, b. AL 1806, moved to TX with wife Ann and 2 children in Jan 1835. Joined the TX Army during the TX Revolution, served at San Jacinto, pvt., Co. D., 1st reg't, TX Volunteers, under Capt. Moseley Baker. Moved to Houston 1837, settled Walker Co. TX 1838, where he d. 1843. A. H. Mason appt'd admin'r of his estate Nov 1843."

For those of you interested in William N. Mock son of Benjamin Mock Sr of Lowndes County, AL...

The handbook of Texas article about him states that he settled in Walker County, TX. This is correct, although at the time he was alive, Walker County was part of Montgomery County. It is in Montgomery County that his probate, with A. H. Mason as administrator, is located.

As for his military service, the muster rolls located at the state General Land Office in Austin show, as stated in the Handbook article, that he served as a private in Company D, 1st Regiment of the Texas Volunteers, commanded by Edward Burleson, and that he was present at the Battle of San Jacinto.

For this military service at San Jacinto he received a Bounty Warrant of 640 acres. The grant was made 28 May 1838 with a survey made for him on 7 Aug 1838 on "McDonald's Creek, a branch of the San Jacinto about 5 miles south from Huntsville." He received another Bounty Warrant, this one for 320 acres, for having served three months from 12 Apr 1836 to 12 Jul 1836 and discharged for disability. This grant was made 10 Jul 1838. The survey was made for him 9 Apr 1839, the land located on Davidson's Creek 20 miles from Nashville. This location would put it somewhere near Caldwell, Texas just west of Bryan/College Station. Each of these grants was patented after William's death, 1848 and 1846, respectively. If the records stated to whom the patents were issued, I did not record that information. A deed in the Montgomery County courthouse dated 6 Mar 1843 records his estate selling the 640 acre piece at a public sale to one John Cot-

On 6 Feb 1838 he was granted a league and a labor of land for having arrived in Texas in Jan 1835 and being "a man of family." He transferred the one labor of land to Ephraim M. Gray on 20 Mar 1841. A survey was made on 4 Jul 1838 for William for the one league of land.

The land was located on Yegua Creek in present day Burleson and Milam Counties. This grant was patented in 1850.

Probate records in Montgomery County state that the

succession of Wm. N. Mock, decd began 29 Nov 1841. Final settlement on the estate was made 26 Aug 1844. It was stated in the course of the settlement that the 640 acre piece was where William died. No other mention of land was made.

According to an article found in the Telegraph and Texas Register, Columbia, dated 17 Dec 1836, "Died, on the 29th, on Lake Creek settlement, Ann Rebecca, youngest daughter of William and Ann Mock, aged one year." I am not sure where Lake Creek settlement is, but Lake Creek runs through southern Montgomery County.

Finally, in the 1850 census for Washington Co., Texas, a William Mock, aged 13 years, b. Alabama, is in the household of J. J. Allen, aged 25 years, b. Alabama. I believe that this William Mock is a son of the subject of this message. The Ann of "William and Ann" was Ann Allen who William married in Montgomery County, Alabama on 27 Feb 1828.

From Washington County, Texas Marriage Records 1837-1870, by Frances T. Ingmire are the following two marriages:

3 Apr 1862 - Benj. W. Mock and Henrietta Holt.
25 Mar 1867 - William G. Blanchard and Henrietta Mock.

I have not had opportunity to dive into these Washington County Mocks. I suppose it is possible that the above mention Benjamin W. Mock could be the William in the 1850 census. It is also possible that these belong to another group of Mocks altogether.

Other Mocks in Montgomery Co., TX

After having written about William N. Mock of Montgomery County, Texas, I thought I would pass along some info on another Mock in that same county.

From Montgomery County, Texas Marriage Records comes the marriage of Randolph Mock and Margaret Hampton on 27 Nov 1838 by E. M. Gray, J.P.

The records at the General Land Office in Austin show a Rudolph Mock who was issued a 2nd class certificate in Montgomery County for 640 acres. As was common at that time he must have sold the certificate, for a Joseph L. Bennett is listed as the assignee. It is Mr. Bennett who has a survey and patent made based upon the certificate. To be eligible for a 2nd class certificate, Rudolph would have had to arrived in Texas after 2 Mar 1836 (or 21 Apr 1836) and sometime in 1837 or 1838. Sorry I can't remember off the top of my head.

The 1839 tax rolls for Montgomery County list a Margaret Mock who was being taxed for a land certificate issued to William Hampton.

And, finally, the Montgomery County Probate Records gives the succession of Margaret Mock. The succession began 26 Apr 1842 with Hugh Hampton as the administrator. The succession of William Hampton, decd. is also. It appears that this Mock may have lived in what became Walker County, for some problems come up with the probate and on 28 Sep 1846, the statement is made "the execution may issue to Walker County."

Walker County was organized 18 Jul 1846. There is no mention of a Rudolph or Randolph Mock in the succession of Margaret Mock.

Does anyone know who this Mock couple is? I think that Rudolph may have been a brother of William N. Mock??

The only basis for this is that they were in the same county after having arrived in Texas within a year or two of each other. They were probably of similar age since one married in 1828 and the other in 1838. Also, if one looks at the 1820 through 1840 census records for Benjamin Mock in Lowndes County, Alabama (William's father) it appears that several girls and one male (who was likely born 1810-1815) are unaccounted for (check the archives for a detailed listing of the known children of Benjamin Mock). This birth of ca 1812 would correspond well with a marriage in 1838.

Most dates of birth and death are from death certificates. The children of John and Sarah Mock are from U.S. Census records, 1900, OHIO, Fairfield County, Lancaster, ED-11, Sheet 13A, Line 45. The descendants of Mary Agnes Dittoe are from her obituary in the Lancaster Eagle Gazzette, 1982 March 8, Page 16, Column 4. The marriage date of Clayton Mock and Mary

Agnes Dittoe is from Saint Mary's records; John and Sarah's, from Fairfield County marriage licenses.

The 1900 census record shows Clarence Mock was born 1876 November; I'm not certain whether this should be considered more accurate than the death record. As the latter would probably win a legal challenge, I give it priority.

In 1827, a petition was filed [with the AR state legislature] for an act to legitimize the children of and legalize the marriage of Mathias Mock. This act became a divorce petition for Margaret Hill from her husband Israel M. Hill and was approved by Governor Izard on 28 Oct 1827. This governor was known to be very much against divorce, and this was the only successful divorce petition in AR that year. The information originally came from the 10/31/1827 and 12/28/1827 editions of the "Gazette" [presumably the Arkansas Gazette].

Rasmussen's SanFrancisco Ship Passenger lists Vols. III & IV

No Mocks appear in the first two volumes of Rasmussen's San Francisco Ship Passenger lists...however there are Mocks abounding in Vols III & IV. No first or given names are listed, only initials.

Vol III - November 07, 1851 - June 17, 1852

Mock, A. B. pg. 134 Ship 'the Fremont or Colonel Fremont', a steamer from Panama, departed from Taboga on 7 Mar 1852, arrived Acapulco on 16 Mar, departed 17 Mar at 5 PM, Saw the brig 'Clarita, which had picked up passengers from the wreck "North America". The 'Fremont' experience constant northerly gales. Arrived in S.F. April 01, 1852.

Mock, W. T. pg. 199

The ship 'Brutus' arrived 57 days from Panama in S. F. on May 24, this list is taken from contemporary sources, some passengers are listed as 'steerage'. W. T. Mock is not among the steerage lists.

Vol IV - June 17, 1852 - January 06, 1853

Mock, C pg. 232 - Arrived on the 'Cortes', a steamer from Panama via Acapulco on January 05, 1852, was off S. F. on the 4th but due to dense fog, could not come into port. Deaths onboard were due to dysentery and fever.

Mock, P.S. pg 217 Mock, W. P. pg 217

The steamer, Golden Gate' from Panama, arrived December 17, 1852 13 days from Panama...via Acapulco, San Diego, Monterey, very thick fog, heavy winds, heavy seas...the hurricaine deck of the Golden Gate was blown clear.

Noah Mock of Ashland Co., OH

"The second murder in this (Ashland) County, OH occurred 17 Dec 1853. The tragedy had its origin in a matter of 7 cents that had been used at a "raffle". The money belonged to one Noah MOCK, but had been appropriated by Thornton Pool, and, in the controversy growing out of this trifling affair, Pool stabbed and killed MOCK. The case was tried at the March term, 1854, POOL found guilty of manslaughter and sentenced to the Ohio Penitentiary for 10 years".

- 2. Mathias Jackson Mauk m. Frances Lea, one of five illegitimate children of Nancy Lea, dau. of old Wm. Lea who died in Wilkes Co., GA 1794. I have copies of the two court cases proving that Nancy was mother of Frances and giving all the children's names, etc. These were in loose papers in Wilkes Co., GA...they were pressing for a division of slaves, as mother Nancy had long since died and the slaves she had inherited from her father, Wm. Lea, were supposed to go to her five children after her death, but one son was keepingthem and not in any hurry for a division...
- 3. Lucinda Mauk m. 6 Jan 1825 Putnam Co., GA to Edwy Liles Vardaman. The couples parents (Thomas Vardaman & Mathias Mock were living next door to each other in 1820 Putnam Co. GA... Census and land deeds prove this. Edwy Liles Vardaman & Lucinda Mauk Vardaman moved to Alabama and lived in Coosa/Tallapoosa Co., AL.....one of the Mock discussions in the archives mentions a Coosa Co. document signed by Edwy Vardaman certifying the heirs of Lucinda Mock, who would be his living children.

 Mielda Vardaman m. 22 Nov 1842 Meriwether Co, GA Israel Thomas Kilpatrick. They moved to Tallapoosa. Coosa Co.AL and to Madison Co., AL by 1870.

5. Mary Lenora Kilpatrick b. 1852; m. Hiram Melvin Jones, my grandmother's grandparents. I have their photograph. He was in Nixon's TN Cavalry and was surrendered by Nathan Bedford Forest at Gainesville AL at the close of the war.

I am a school teacher, living in Shelby Co., Montevallo, AL. I live in my ancestor's 1816 log cabin. I have done genealogy since I was 13 years old and have grown up surrounded by ancestry. I am the seventh generation to be in the county on several of my lines.

What a nice surprise to see my family in the Spring 1998 issue of the "MFH". I'm sorry to tell you there is a mistake on our Samuel John Mock who married Marguerite Duncan, b. 11 Jan 1852 and died 14 Oct 1881. Their son, Oliver Ray Mock, b. 12 Jul1881, died 13 Sep 1881. Both Marguerite and her son, Oliver are buried in the Norman Cemetery, Ellis Co., KS.

Samuel John Mock m. (2) Emma Chaney at Dodge City, KS 12 Jan 1886. They had 8 children. Samuel John and Emma stayed in Meade, KS for 10 years then went to Peck, KS for awhile, then on to Trinchera, CO. They are both buried at Trinidad, CO. I have visited these graves.

Michael Mock of Franklin Co., PA/OH

Michael Mock's second wife was Catherine O'Farrell (Franklin Co. Probate Court, Columbus, DAR Transcript 5/347). Michael was vouched for by Joseph Mock, presumably because of Michael's age and attesting that he "had all his marbles." Michael and Catherine m. 1851.

The following is a paragraph from the researcher I hire in Columbus:

"I am pretty confident that the Michael Mock who married Catherine O'Farrell was the old man, for Catherine was a fairly old woman. The fact that Joseph vouched for Michael probably does indicate that there was some concern of senility. For minors, one did not vouch, a parent gave "consent". James O'Farrell of Clinton Township died 1 May 1849...The 1850 census shows her, Catherine O'Ferril, aged 60 years, b. in PA, two houses away from joseph and Michael Mock...marriage took place in 1851. On January 5, 1853, E.H. O'Ferrall and Catherine Mock leased "the James O'Ferrell farm," 25 acres in Clinton Twp. to Senn & Keopfe (??). (Deed record 49/238). Catherine must have died by 1862, for the next record I can find is Jan. 4, 1862, E.H. & Jane O'Ferrell sold to Joseph Mock..."

As an aside, according to Don [researcher], the Joseph Mock farm was to the west of the O'Farrell place. This farm had been sold by James O'Ferrell and wife Catherine to Michael Mock, Jr. in 1836 (deed 16/49). To my knowledge, there is no question that Joseph was a son of Michael & Margaret.

According to information from Verne Wright, Michael's second wife was Elizabeth Holmes.

The only reference I've seen to Michael's wife being named Elizabeth is on my g-grandmother's interment record at Greenlawn Cemetery. On that record her parents have been listed as Michael & Elizabeth Mock. I have nothing else to substantiate that he was ever married to an Elizabeth and am operating under the presumption that this is an error. It wouldn't be the first time someone has misspoken a relative, especially in times of stress.

My researcher in Columbus, OH did a quick check of the deed indexes and in each case Michael Mock's wife is named as Margaret. They took title to 150 acres in 1834 in Clinton Twp. In 1845 Michael & Margaret conveyed 150 acres to Joseph Mock; same year they conveyed 75 acres to Casper Kiner.

Michael Mock Obituary

Some time ago I came across a book: Index of Death Notices and Marriage Notices Appearing in Cincinnati Volksfreund 1850-1908.

According to the introduction in this book, Cincinnati Volksfreund was a newspaper published in the 1800's for German speaking immigrants of Cincinnati and published daily.

The following is a translation of an obituary appearing in this paper on 04 & 05 January 1876. Translation is by Rich Heinemann with my greatest thanks and appreciation.

Death Notice

Died on Monday, the 3rd of January 1876 at 20 minutes before 9:00 in the evening, our dearly beloved husband, father, fath-in-law and grandfather, MICHAEL MOCK at the age of 76 years, 1 month and 19 days.

The funeral will take place on Wednesday, the 5th of January, at the home of his son-in-law, John Schonenberger, No. 535 Baymiller Street, to which all relatives, friends, and acquaintances are cordially invited by the grieving survivors: Margaretha Mock, nee Keller, wife; Katharina Schonenberger, nee Mock, Margaretha Drofte, nee Mock, Maria Schumacher, nee Mock, daughters; John Schonenberger, Friedrich Drofte, Friedrich Schumacher, sons-in-law; besides 14 grandchildren.

I don't know who the parents of this Michael Mock were. This obituary is very tantilizing to me as Michael Mock who married Margaret Whissinger had a son, Michael, born 1800/1810. The last record I have of this child is the 1830 census of Franklin Co., OH. This record indicates Michael (age 20/30) living with a woman (age 20/30) presumable his wife. In the household were 4 children: 1 male to age 5; 1 male 5/10; 1 male 15/20; 1 female to age 5.

Catharine Mock Schonenberger d. 11 Apr 1903 at age 62y2m9d which would put her birthdate about 2 Feb 1841.

Does anyone have further information on this family Michael Mock?

Peter Mock of Bedford

number of years ago I set about finding the source for the name SAMPLE as the maiden name of Peter Mock's wife. It led me to Elizabeth R. Taylor of Plum, PA in 1988. In her answer to me, she said that she had found it in a will in Bedford Co., PA. will Book 1, page 590, Will of Ludwick SAMPEL, Jr. The will refers to "Adam Mock, son of my sister, Elizabeth" (Mrs. Taylor gave this information to Mrs. Louise DeMars, who then included it on her DAR application in 1984 and it has been passed around since).

A few years ago, I made it to Bedford and looked up this will. I found it on pp 277-8, dated 1809. It also mentions other siblings (namely his brother, Adam and his sister, Susanna) and his "beloved mother Christina SAMMPUL". You bet I got excited - having another generation until I did some mental calculations. Digging further disproved this Elizabeth Sample Mock and her son, Adam as being the wife and son of our Peter Mock.

I submit the will of Adam SAMMEL, Book 1, pp 87-80, dated 1798. This will leaves his land to his son Ludwick until March of 1804 when Adam's youngest daughter reaches 18. The will mentions by name Adam's three sons—Ludwick, Michael and Adam; his four daughters—Christina, Susannah, <u>Elizabeth</u> and Evah as well as his wife, Christina.

Probate of Adam's estate shows that in 1799, Elizabeth, his daughter and Ludwick's sister is below the age of majority. Therefore it is impossible that this Elizabeth is the mother of our Mock Line. (Our Adam, b. 1785).

Further investigation in the land records show that the land in both of these wills is the same. Here the name is also SAMMUL.

I have sent a copy of this letter to Fred Ickes. I'm sure that Fred will agree with my conclusion and that the "Mock Family Historian" will print a denial of what is becoming a widely disseminated fallacy.

I have sent my reservations for the Bedford conference and am looking forward to meeting many of the people I have written to over the years.

Ed. Note - I have the following information on my "Working Chart" for the Peter Mock: "Peter Mock married 1767 Washington Co., MD Elizabeth Sample, b. 1747 Washington Co., MD; d. 1813 St. Clair, buried Hominy Hills. Where did this come from???

Going through old files I came across two different members, Barbara Urban (former member) and Jerrian Barness, who claim that Peter Mock married Elizabeth Garn. I have found no documentation for this claim.

From Jerrian Barsness - MOCK GENEALOGY

Immigrant Ancestor: PETER MOCK Born in Germany in 1742 and died in Bedford Co., PA 18 Feb 1817, age 75 yrs. Came to PA between 1750 and 1758 and served in the Revolutionary War. He married about 1765 in Maryland, Elizabeth Garn b. 7 Sep 1743/1747; d. 7 Sep 1816 (1813? on grave). She was of German parentage and had her first child at age 19 and her last at age 48. (The Mock and Garn families seem to be closely connected both in names and places of residence.)

I'm sure that this will be discussed at the conference, and hopefully an answer will be found!
