# GEORGE AND SOPHIA MOCK FAMILY Traced From Pennsylvania to Virginia

After more detailed study of the Emanuel Lutheran Church Records found at the L.D.S. Library in Salt Lake City, it can now be shown that George and Sophia Mock and children moved from near p esent day Bricker-ville in Lancaster County, Pennsylvania to near Middl town in Frederick County, Virginia. This move occurred sometime after 1773.

This family was discussed in the October 1991 Mock Family Historian, pages 11-12, under "Which George Is Who???".

George Mock married Sophia Miller/Muller on April 21, 1761. The names and birthdates of their children are reprinted below as found in the "Records of Pastoral Acts at Emanuel Lutheran Church, Known in the Eighteenth Century as the Warwick Congregation", and translated by the Pennsylvania German Society in 1983.

For many years the will of Christopher Mock, proved April 4, 1809 in Frederick County, Virginia, has puzzled researchers. Abstracts of the will have been widely circulated, but in late February 1992 Dr. Ronald Moore obtained a copy from the clerk of the Circuit Court of Frederick County at Winchester, Virginia. A copy of the Estate Settlement of February 1, 1825, was also obtained. Excerpts of interest include

"I bequeath unto my ... wife Rozena Mock ... the entire estate of which she was in possession prior to my intermarriage with her ... and one half of the moveable estate left to me by my father, together with my own. I give and divise to my brothers and sisters DANIEL MOCK, GEORGE MOCK, CATHARINE EVERLY, CHRISTIANA HARMON, and SUSANNA MOCK ... share and share alike. My house and lot in Middletown I wish rented ... which rents arrising I give unto my mother ... After her decease I desire said house and lot, and my share in the land demised by my father to me, be sold and the money ... equally divided amongst my brothers and sisters ... I appoint my ... friend Abraham Niswander as my sole executor."

Signed 10 January 1809 "Christopher Mock" Witnesses: Lewis Amiss, John Snyder, F. Martin

The estate was not settled until February 1, 1825. Perhaps Christopher's mother did not die until the prior year. The estate account lists many payments, some by date. On June 7, 1810, SOPHIA MOCK was paid 30 dollars. An amount not legible was paid to "Everley's sons". Entries under the estates assets include two final notations: "By his share of money left by his mother - \$35.33. By the sale of his lot in Middletown - 101.00".

Christopher Mock married Rosian Baker on Oct. 14, 1808 - bond, George Mock. (Shenandoah Co. Marriage Bonds)

The <u>Harman Genealogy</u>, by John Harmon, states as a direct quote, on page 303: "I, JACOB HARMON, was born Aug. 11, 1769. My wife CHRISTENA MOCK was born Jan. 26, 1769. I got married Oct. 29, 1797."

Finally, in the book <u>Floyd County</u> (Virginia), by Dr. Amos D. Wood, we find this biography of Jacob Harmon:

"Jacob Harman (Aug. 11, 1769-1829) married Christina Mock (Jan. 26, 1769-1839) daughter of George and Sophia Mock of Frederick County, Va., on Oct. 29, 1797. They lived in Frederick County until 1802 when they moved to present Floyd County. He bought 326 acres of land on West Fork of Little River ... where they lived until his death. Jacob and Christina were members of Zion Lutheran Church near the courthouse, where some of their children were baptized. They had ten children." (The children and descendants are listed in book.)

Thus we have overwhelming evidence linking these Shenandoah Valley Mocks to Lancaster County Mocks in Pennsylvania. We still are left with many unanswered questions. Who are the parents of George Mock married to Sophia? What became of Daniel Mock, born Dec. 8, 1763? What connection, if any, do these Mocks have to the other Mock families of Shenandoah Valley?

Searching JOHN MOCK, b.23Jun1806 Rowan Co., NC. His parents are John & Catherine Graves MOCK who were married 4Oct1790, Rowan Co., Peter MOCK was bondsman. John & his older brother, George were in Coles Co., IL in 1830.

A biographical sketch of George in Coles Co. says his father John was a farmer & carried on a distillery, and that he died when George was very young. George migrated west to Orange Co., Indiana and married there in 1819 to Lucinda Pippin. Was John with him??? John m. Eleanor Tennery on 28 Jan 1836 in Edgar Co., IL. He must have been married before as there are 2 girls living with he & Eleanor & family, Sarah J. (m. Gibbons), b.ca1832 and Mary

b. ca1833. All information on this family will be appreciated.

My direct ancestors are daughters, Barbara who married Joseph Isaac Kirk 1802, Greene Co.TN and Mathena Jane (Jenny) who married Wm. Hartley 1807, Greene Co. I am descended from DANIEL MAUCK (1740 VA) and his second wife, Rebecca Baker through their son, Joseph. I am particularly interested in the fact that DANIEL MAUCK insisted upon signing his name MAAG. I find that MAAG is an old German name dating back to the 1200's. Mauck is also an old German place name. I think that the county clerk that made out the handwritten documents may have misunderstood Daniel when he pronounced "MAAG" and mistook the name to be that of an already familiar MAUCK (Peter MAUCK) in the area. Rudolph Sr. who is presumed to be Daniel's father also was known as "RUDEN MAG" on some documents.

Susanna Charlotta Waltz was b. 6 Oct1746, dau. of Georg Heinrich Waltz and Dorothea.

#### PHILIP MOCK

submitted by LOUISE CLARK to the ROWAN CO.,NC REGISTER Vol. 7, No. 2, May 1992

The Diary of Johann Gottfried Arends shows that he married PHILIP MOCK to Anna Mariah Klinert 10Mar1776 at Ebellscriik (see p.676 RCR); she was the daughter of Philip Clinard. Rowan Co. Deed Book 8:458 shows that the following year Henry Harman, a blacksmith who signed in German, and his wife Nancy sold Phillip Mock for L300 proclamation money, 205 acres on both sides of Abbotts Creek bought from John Delashmit. Witnesses to the deed were James Welborn and Henry Davis. The deed was proved by Davis at Feb. Court 1778. Mock was numbered among those who took the Oath of Allegiance on 5 Aug 1778 (P & QS, Bk 4:159). Philip Mock acquired over a thousand acres of land and more than a dozen slaves; he was a "Retailer of Spirits," among other things. His first wife, Anna Maria (Clinard) Mock, died about 1782 and Philip Mock's next wife was Mary Magdalene (maiden name unknown) by whom he had nine additional children. After 1810 Philip Mock married Hannah Walk, dau. of Martin Walk. On 17Feb1824 Hannah Walk Mock married John Clodfelter, Jr., and they subsequently moved to Missouri. Philip Mock had a brother Devolt Mock who married Phebe Clinard, also a dau. of Philip Clinard. She moved to Greene Co.,OH with her children and there married Asa Oglesbee. Philip and Devolt Mock were sons of Johannes Mock whose Berks Co.,PA. Will is dated 15Apr1782.

ROWAN RECORDS SLEUTH - The will of Philip Mock, Sr.,dated 2June1819, and signed by him in German, is not recorded in the Rowan Co. Will Books but survives among the original Wills at the North Carolina Archives. This is the Will of a prosperous settler in the area of Rowan that became Davidson Co, a man with married grandchildren and a wife young enough that the prospect of children in esse was a possibility. The Will is even more interesting in that it was witnessed by one of the legatees, David Mock, son of the testator and the first Clerk of Court in the newly formed county of Davidson, a man of success, as the records show, lay on something firmer than his ability to manage money. The law, then and now, stated that a man who receives by a Will cannot be a witness to it. But the signature of the witness and that of the son and co-executor are undeniably identical. The invalidation of the Will by the legatee-witness provides the reason the Will was never probated.

### MOCK FAMILIES IN 18th CENTURY GEORGIA

BARTHOLOMEW (Bartholomaeus) MOCK (Mackh, Mack) was born 1730.

1 Jul 1755 he married Maria Stand (Stund) in Effington Co.

In 1759 he received land grants of 50 acres in Bethany and 200 acres in St. Matthew

10 Jun 1758, dau. Maria Barbara was born.

20 May 1760, son Michael was born. He died Nov. 4, 1761.

16 July 1761, son Paul was born.

13 Aug 1763, Dau. Maria & son Thomas (twins) were born.

Bartholomew died 12 Jan 1764. buried in Bethany, Age 34 yr. 2 mo. His widow Maria remarried to George Fischer on 29 May 1764.

THOMAS MOCK (Moch, Mackh) possibly arrived on Capt. Brown's ship, 27Nov1752 In 1759 he received land grants of 50 acres in Bethany and 100 acres in St. Matthew. 16Apr1765, he married Maria Weinkauf in Effington Co.

WOLFGANG MOCK (Mack, Mackh) was Schwabian from Langenau by Ulm. He arrived in Capt. Brown's ship 27 Nov1752.

24 Feb 1755 he married Anna Barbara Mayerhoefer in Effington Co. She was a widow from Purrysburg.

Wolfgang died Nov 1775

JACOB MOCK (Mack, Meck) was from South Carolina.
In 1761 he received 200 acres in St. Matthew's Parish.
He was present there in 1774 and was listed as a witness in 1779.

JONAS MOCK (Mack) was listed in 1755 in the "Cattle Brand Book", residing in Goshen.

JOHANN MARTIN MOCK (Mack) was Moravian, arrived 1736, departed 1740, and died in 1784 at St. Croix.

MICHAEL MOCK (Mack) was listed as a Ranger in 1758 He was present in Georgia records of 1774 and 1783. Oct 1776, son Johann Michael was born.

CHRISTINA MOCK (Mack, Mackh) married Matthew Weinkauf 12 Apr 1768 in Effington Co.

ANDREW MOCK received 300 acres in Richmond. 1791. GEORGE MOCK received 100 acres in Warren Co. 1797. JOSEPH MOCK received 200 acres in Richmond, 1790. JOSEPH MOCK received 300 acres in Effingham 1795.
