"In the summer of 1632 his [Daniel's] father was lost in an accident at sea and his oldest brother became the head of the family, as prescribed by English Common Law. This created an unbearable situation for Daniel and Joseph for they had a poor relationship with that brother. Their presence must have been just as disagreeable to the older brother as he agreed, that fall, to pay their way to America and give each 10 pounds to finance the trip. Probably the reason he agreed so readily to bear that expense was, due to the law, he was responsible for their support and welfare. By financing their way to America he removed that responsibility forever. Passage was arranged on the ship 'Mary and John' of London which was scheduled to sail for New England after Christmas of 1632."
