To all to whom these Presents shall come, GREETING :

KNOW YE, That in Pursuance of the Act for opening the Land Office, and by virtue of the
Power is invested, I HAVE, by and with the Advice and Consent of the Honorable the
Executive Council, given and granted, and by these Presents, in the Name and Behalf of the
said State, DO give and grant unto *Henry Starr, his*

Heirs and Assigns forever, ALL that Tract or Parcel of Land, containing *Two*
hundred Acres, situate, lying, and being, in the County
of *Wilkes* in the said State, and butting and bounding *North*
wardly by *John Gelbreath's and*
vacant Land, and on all other
sides by vacant Land

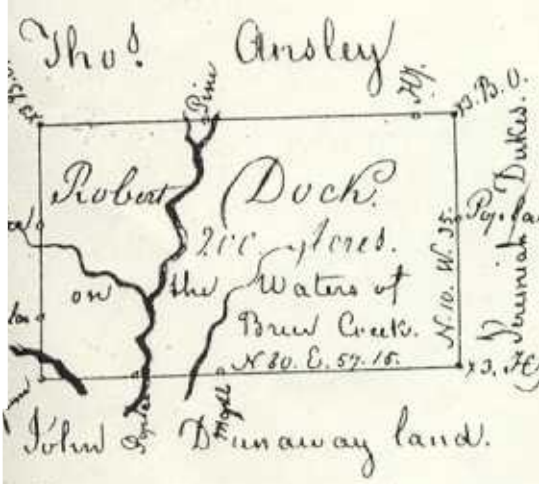
having such Shape, Form, and Marks, as appear by a Plat of the same hereunto annexed ;
together with all and singular the Rights, Members, and appurtenances thereof, whatsoever, to
the said Tract or Parcel of Land belonging, or in any wise appertaining ; and also all the Estate,
Right, Title, Interest, Claim and Demand, of the State aforesaid, of, in, to, or out of the
same : TO HAVE AND TO HOLD the said Tract or Parcel of Land, and all and singular the
Premises aforesaid, with their and every of their Rights, Members, and appurtenances, unto
the said *Henry Starr, his* Heirs and Assigns, to *his* and
their own proper Use and Behoof forever, in Fee-Simple.

GIVEN under my Hand in Council, and the Great Seal of
the said State, this *twenty fifth* Day of
November in the Year of our Lord, One Thousand
Seven Hundred and Eighty Eight and in the
fifteenth Year of American Independence.
Signed by His Honor the Governor in Council the *25.* Day of *Nov* 1788.

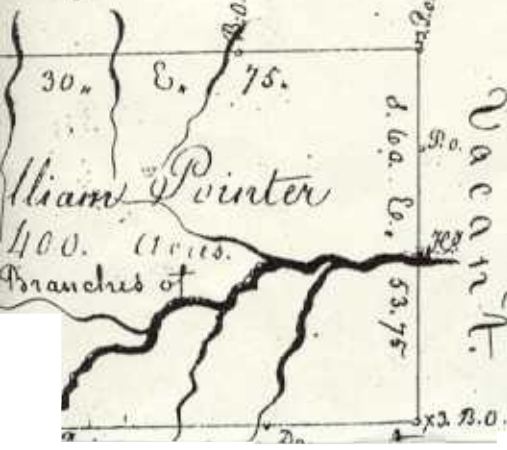
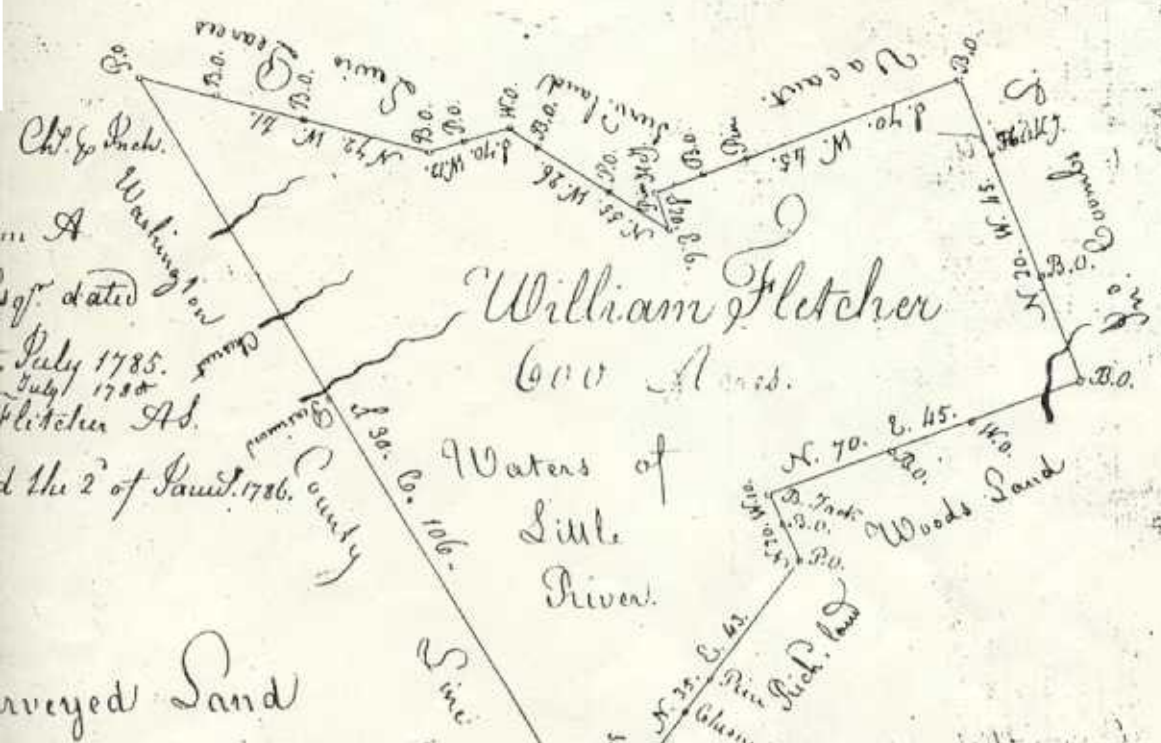

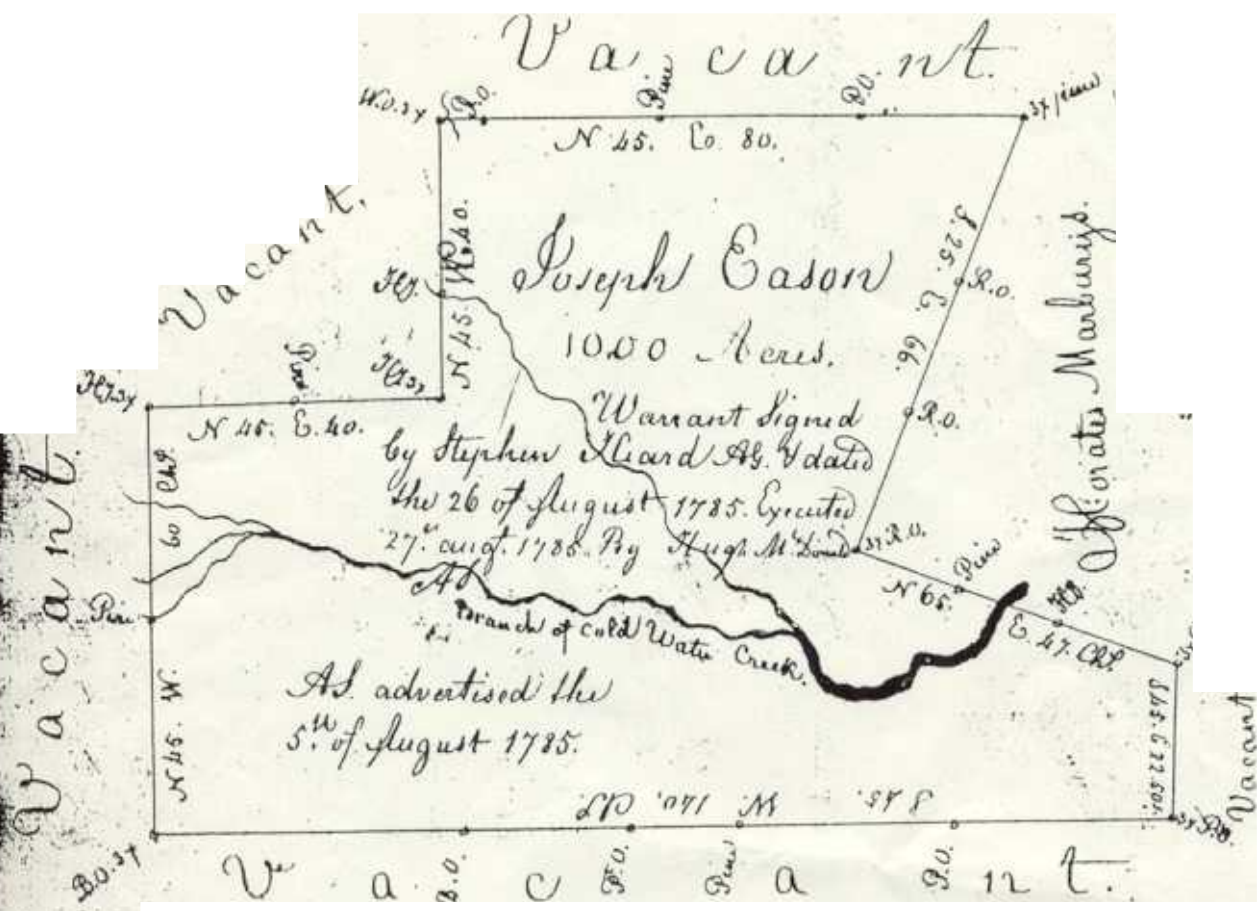
