In the name of God I Jacob Anthnoy of said County and State aforesaid do by these present make and declare this my last Will and Testament as follows, to wit, 1st I give and bequeath to my daughter Mary Moser my plantation where I now live on containing one hundred and forty acres be the same now or life agreeable to my deed to her and her use and her heirs forever. Subject to the following conditions (to wit) by my daughter Mary Moser paying to each of my twelve other childern them or their heirs the sum of fifty dollars apiece paying the first payment within a year after my death to my oldest son Jacob then each in according to senority until the whole of my twelve children the sum of Fifty dollars apiece. 2nd I do nominate and appoint my son Henry Anthony and Adam Albright to be my Executors to act on this my Last Will and Testament. 3rd After my death my wish is to have all my household and kitchen furniture stock and all moveable property sold and divided equally amoungst my thirteen children in number. I was born the first day of May in 1745. In Testamony heresaid I do hereby declare this to be my Last Will and Testament hereby revoking and disannulling all other wills by me heretofore made and do declare this to be my last Will and Testament and hath hereto set my hand and seal this thirty first day of July One Thousane Eight Hundred and Twenty Eight.
